VOLUNTEER PARTICIPATION AGREEMENT AND RELEASE OF CLAIMS,  
WAIVER OF LIABILITY, AND ASSUMPTION OF RISK  
PLEASE READ CAREFULLY**

**I, THE UNDERSIGNED**, on behalf of myself, my heirs, executors, administrators and assigns, in consideration of local reps Tim Fan, Michael Hewitt, Julie Huang, Andrew Syyong, along with directors Chung Yan Ip & Rich Ng, permitting me to accept the optional bus transportation to the Delta Grand Okanagan Resort, 1310 Water Street, Kelowna, BC on Tuesday December 27, 2011 and a return trip back to Vancouver, BC on Saturday, December 31, 2011, do hereby release and discharge the “local reps”, church reps, CCCYWCM, CCCWC, Winter Conference, its board of directors, agents, servants, employees, executors, administrators and successors and assigns, from all manner of actions, causes of action, suits, proceedings, liabilities, debts, dues, claims, demands, and obligations whatsoever, at law or equity, which the undersigned has had, or has, or shall or may have by reason of any cause, matter or thing, including negligence on the part of the “local reps”, church reps, CCCYWCM, CCCWC, Winter Conference, its board of directors, agents, servants, officers, employees, in connection with arising out of, either directly or indirectly such activities of the bus transportation and all related activities. I agree not to make claim against any person or corporation who might claim contribution or indemnity against the “local reps”, church reps, CCCYWCM, CCCWC, Winter Conference, its board of directors, agents, employees, officers, in connection with or arising out of, either directly or indirectly, such the Retreat and all related activities.

I am aware of and understand the risks, hazards and dangers inherent in the bus transportation service and related activities, which include but are not limited to the possibility of personal injury, death, property damage or loss resulting therefrom, and travel to and from the location of the Delta Grand Okanagan Hotel. Notwithstanding the inherent risks, hazards, and dangers. I request the local reps allow me to participate in the transportation service and all related activities and I hereby agree to assume all risks in engaging in such activities, including travel to and from the location of the Delta Grand Okanagan and related activities.

I AGREE, and am aware, that as a condition of being allowed to participate in the bus transportation service and all related activities, I do warrant that I am in good physical and mental health and that I will not consume alcoholic beverages or any other substances, such as would impair my senses, while participating in the transportation service and all related activities.

I HEREBY ACKNOWLEDGE that I have read this Agreement and understand that it is a full and final release and waiver of all my claims for damages or injuries sustained as a result of my participation in the bus transportation service, and that I am voluntarily discharging the “local reps”, church reps, CCCYWCM, CCCWC, Winter Conference, its board of directors, agents, servants, employees, executors, administrators and successors and assigns of all liability for any losses and damages which I may sustain.
